Deerfield Rod and Gun Club - Range Rules and Regulations

1. Anyone using the ranges must be a member and follow all posted and published rules and bylaws and carry and show their card to anyone inquiring about your membership status. *(No Guest shooters)*
2. No Member shall be under the influence of intoxicants or other drugs while using the Ranges.
3. Irresponsible shooting, reckless conduct, shooting into signs poles, posts or other gun club property or *violation of Safety Rules will result in expulsion from the club and criminal charges.*
4. Use of Rifle or Pistol Ranges is prohibited before 8:00 am and after sunset as indicated by time in newspaper.
5. Trap range shall close no later than 10:30 pm.
6. When using the pistol or rifle ranges, all targets must be placed in front of the berm and in front of or attached to the target holders. Shooting in the ground is strictly forbidden.
7. No Fully Automatic weapons or Tracer rounds are allowed on the ranges.
8. All used targets, expended rounds or casings, and other refuse, must be removed and placed in the designated garbage containers.
9. Children and pets must be closely supervised on the ranges, below the clubhouse, or in the woods area.
10. Updated rules may be published on the club website www.deerfieldrodandgunclub.com and/or posted in the clubhouse and/or Ranges
11. *Youth Members not having completed Hunter Safety: The Deerfield Rod & Gun Club will follow the guidelines as published in the current WI Hunting Regulations under the Mentor Program.
12. *Any member found in Violation of any club rule, bylaws, or regulations may be expelled from the Club with no refund due and prohibited from the use of the club or its facilities.*

I hereby accept a membership in the Deerfield Rod and Gun Club (DRaGC) and submit payment for the Calendar year (Jan 1-Dec 31). I pledge to obey and abide by the Club's By-Laws, Rules and Regulations both as stated here and as may be updated in the future. **I acknowledge this as my temporary membership and will attend a new member meeting to received my member card. I will attend a Member meeting within 60 days to receive my card.**

This agreement releases the DRaGC from all liability relating to injuries that may occur during any activities at the DRaGC. By signing this agreement, I agree to hold the DRaGC entirely free from any liability, including financial responsibility for injuries incurred, regardless of whether injuries are caused by negligence.

I also acknowledge the risks involved in activities at the DRaGC. These include but are not limited to archery, handgun, rifle and shotgun shooting, including the firing of live ammunition; observing individuals discharging firearms; and any other use of or activity on the Premises, including the land and buildings located thereon. I swear that I am participating voluntarily, and that all risks have been made clear to me. Additionally, I do not have any conditions that will increase the likelihood of experiencing injuries while engaging in the activity.

By signing below, I forfeit all right to bring suit against the DRaGC for any reason. In return I will receive participation in DRaGC activities. I will also make every effort to obey safety precautions as listed in writing and as explained to me verbally. I will ask for clarification when needed.
