

DEERFIELD ROD & GUN CLUB

CLUBHOUSE RENTAL AGREEMENT/CONTRACT

The renter of the clubhouse hereby agrees to follow the following rules & regulations:

- The fee to rent the clubhouse for private events is \$350.00 for members with 3 years good-standing and \$900.00 for non-members. This price includes one bartender for the downstairs bar for up to 6 hours. Should your function require more than one bartender, an additional bartender can be added for \$10.00 per hour for the 6 hours. If your event exceeds 6 hours, an hourly charge of \$25.00 per bartender will be added to the balance. If your event includes the use of trap ranges, there will be a \$25.00 per hour charge for a Range Safety Officer, with a two-hour minimum rental. If an event is held on a day that the clubhouse is open to the public (i.e., Sundays) the upstairs can be rented with no bartender for \$200 for members and \$600 for non-members.
- Local community organizations that are approved through the board of directors to rent the clubhouse may do so at a reduced rate, subject to the discretion of the board of directors.
- All fees must be paid 60 days in advance. In the event of cancellation, the following forfeitures shall be followed:
 - If cancellation takes place more than 30 days prior to the event, a full refund of the deposit will be awarded. This includes all half barrels ordered.
 - If cancellation of the event takes place within 30 days of the scheduled event, a refund of half the deposit will be awarded. No refunds for half barrels if cancelled within 30 days of event.
 - To ensure the club is left in a responsible manner, a \$200.00 security deposit will be collected to secure the date. All remaining fees owed for the event are expected to be paid on the day of the event.
- ½ barrels of beer, if desired, MUST be purchased through the club at a price of \$150.00 for domestic and \$200 for specialty, with a maximum of 2. Barrels must be ordered at the same time as the rental agreement is signed. Additional beverages may be purchased over the bar, NO CARRY INS ALLOWED! Any and all alcohol must be served by licensed bartenders.
- Renters are responsible for set-up of hall. This includes moving tables and chairs and any decorating. No decorations may be nailed or stapled into the walls or ceiling. Decoration plans must be approved prior to installation by Deerfield Rod & Gun Club. All cleanup/take down must be accomplished no later than 12:00 PM the day following the event.
- Renter is responsible for any damage to the clubhouse or its contents.
- Absolutely no underage persons will be allowed without a parent.
- The Deerfield Rod & Gun Club assumes no responsibility for any loss or injury and renter will hold Deerfield Rod & Gun Club harmless of such. All renters must abide by club policies and procedures.
- For events having music, music is not to go past 12:00 AM and the bar will always be shut down NLT 1:00 AM.

We are happy to open our doors for your rental experience. Please remember that we are a Gun Club. Ranges will not be closed for your event so keep in mind that members may be shooting.
